#### Reminder of the objectives:

- Harmonise national law within the limits set by the Directive
- Reduce the cost of cross-border credit
- Allow better account to be taken of creditors' interests
- Increase the predictability of procedures
- Facilitate the debtor's recovery
- Harmonise discharge of debt derogations by transposing Article 23 of the Directive
- Enhance judges' skills and improve support for professionals

The means proposed to achieve these objectives :

- Generalised implementation of preventive procedures
- Generalised rebalancing of debtor-creditor relations with the formation of classes of affected parties with the right to vote on the restructuring plan
- Harmonisation of the arrangements for discharging debts with the emphasis on expeditious treatment of procedures
- Harmonisation of the organisation of the bodies handling the procedures, in particular training and specialisation of lawyers, the professional organisation of insolvency practitioners and their specialisation
